Adam: Idea of supplemental budget

Leimomi: GGU community and I spoke to co-workers about what their input was.Something that could service GGU members and families would be continuation of scholarship. GGU baseball team? ASEA vs other juneau softball players.

Paul: Like the idea of multiple proposals like scholarships and supporting the community overall. Glory Hall is time-sensitive.

Adam: Could have regular budget and supplemental budget...not encumber the full 70,000 and bring another supplemental budget later if member comes with proposal. Bring budget committee budget for a vote and then supplemental: specific things with specific values with scholarship and Glory Hall. Let members know that it can still be budgeted.

\$5500 for Glory Hall Office and there is another insulation project at \$7,000.

Adam: I move that we present a supplemental budget to the membership to include at least one item: \$5,500 for the Glory Hall renovation and up to \$5000 for 5 \$1000 scholarships. Leimomi seconds. Motion passes.
