

'How Your Union Works For YOU" was the topic of the last round of ASEA/AFSCME Local 52 worksite meetings held from March thru May, 2014. Business Agents and Organizers spoke to ASEA members about three major subjects: ASEA Local 52's History and Collective Bargaining, the Social/Community Impact of Unions and Legislative Advocacy.

Past & Present

The union believes it's important for all members to have a fundamental understanding about the history of collective bargaining, of where and how our local came about and about what protections and rights one has as a public employee, specifically related to the Public Employment Relations Act (PERA). Collective bargaining was explained in terms of the method, what due process in the workplace means to all our members and what benefits are gained through consolidating a group's collective strength to benefit the whole (ex. various leave banks, health and legal trust, geographic differential, etc.).

Members were given specific examples of how unions internationally, nationally and locally press for better social and economic policies during the 'Social/Community Impacts of Unions' section of the agenda. Poverty is unprecedentedly higher and extremism is allowed to thrive on the hopelessness of the people in countries that have depleted or eliminated unions. World Bank and International Labor Organization studies were cited as examples of how lower unemployment and inflation, higher productivity, speedier adjustments to economic downturns and low levels of wage inequality are all benefits that union rich nations enjoy.

In the 'Legislative Advocacy' section, the informed membership was about the importance of staying educated concerning legislation, especially since member jobs and livelihoods are tied to budgets and bills passed which can directly affect everything related to one's employment. ASEA's volunteer-financed PAC endorses candidates and causes each election year based on a varying number of factors, all having to do with the individual member and socio-economic benefit to the community as a whole.

Starting in August, the new round of worksite meetings will focus on 'Your Local Chapter.' Emphasis will be placed on who they are, what they do, when they meet, the community outreach and events they sponsor and how you can get involved. Chapters carry out the goals of the union on a regional and occupational level while undertaking items of community importance such as support for local charities and scholarships.

ASEA/AFSCME Local 52 wants your union to run according to your thoughts and ambitions and those of your fellow members. For that to happen, as with any democratically run organization, it requires more than an educated membership with ideas - it takes curiosity and motivation.

Plan to attend the next round of worksite meetings that start at the end of August. Learn more about how you and your fellow members contribute to and participate can in community chapter activities.
