# General Election - ASEA PAC Endorsed Candidates

ASEA/AFSCME Local 52 recommends the following list of candidates for the upcoming General Election to be held on Tuesday, November 4. Recommendations are based on questionnaires returned by the candidate and legislative voting records. ASEA/AFSCME Local 52 endorsement for public office is based on the candidate's support for public employee issues, not party affiliation. The following recommendations reflect political positions that ASEA/AFSCME Local 52 believes are in the best interest of public employees.



Walker & Mallott For Governor & Lt. Governor

Bill Walker for Governor (U)

Byron Mallott for Lt. Governor (D)



Bill Walker and Byron Mallott announced their joint candidacy. They believe that their decision to move ahead as a team is in the best interest of the state. They believe that the state is on the wrong course. Both believe that there is a great deal at stake, and that their combined ticket is a strong and balanced partnership that is the best choice for moving Alaska forward.

**WALKER** - I am running for Governor because it is time we, as Alaskans, take control of our future. Issues I see facing Alaskans today are:

- ◆ Oil & Gas Alaska is in an energy crisis now and we are doing little to solve this crisis.
   Alaska is facing a huge fiscal cliff as the result of declining oil revenues.
- Energy Crisis Immediate steps need to be taken to get economical energy to Alaska's communities.
  - Alaskans cannot continue to pay these exorbitant prices for energy and wait for Alaska to start over and still not come up with a solution for economical energy.
- ♦ Health Care We must increase the number of health care providers throughout the state.
  - I support the Medicaid expansion with the caveat of continued federal funding— 4,000 new Alaska jobs would be created and lower-cost coverage for 40,000+ Alaskans would be provided.
- ◆ Education Our public schools must be adequately funded.
  - It is the quality of our teachers, not our facilities and equipment, that make the critical difference.
  - Our focus needs to be on attracting and retaining the very best educators who approach their positions as a calling, not just a job.
- ♦ Jobs for Alaskans
- **♦** Tourism
- ♦ Alaska Marine Highway
- ♦ Fish Management
- **♦** Agriculture

**MALLOTT** - I know that polarizing partisanship is not how solutions are achieved. It takes leadership and hard work. This campaign is about building a better Alaska and who's best prepared to get us there.

- ◆ My first priority is education It grows everything else, from universal voluntary pre-K services to timely predictable K-12 funding, expecting excellence in the classroom and reducing student loan interest rates.
- ◆ I will coordinate and consolidate the efforts to bring affordable power and fuel to all Alaskans (there's no single answer, there can and should be a singular focus on energy at the highest level). Energy costs are crippling, Alaska faces critical choices not in 10 or 20 years, but now.

### Minimum Wage Initiative (Ballot Measure #3) Vote "YES"

Alaskans will have a chance to vote to increase the minimum wage to a more appropriate level, one which will help everyday hard working Alaskans and their families afford the basics, such as food, medical care and housing. This measure includes a provision maintaining it against inflation. Alaska had America's highest minimum wage for 40 years and enjoyed unprecedented growth. Today Alaska's minimum wage is only 50 cents higher than most states.

Alaskans for a Fair Minimum Wage (AFMW) was started in March of 2013 by three former Alaska State Labor Commissioners to advocate for the raising of the Alaska minimum wage to a level that would help Alaskan's provide for themselves and their families. On April 26, 2013, AFMW submitted the application to the then Lt. Governor for permission to begin collecting required signatures to place this measure on the 2014 ballot.

Thirty-thousand one hundred and sixty-nine (30,169) signatures were needed to place this measure on the ballot. From July 2013 to January 2014, one hundred and fifty (150) volunteers collected 43,489 signatures throughout the state.

On February 2014, the Division of Elections confirmed that the 36,480 signatures were valid and met the requirements to become Ballot Measure 3

This measure proposes that the Minimum Wage be raised from \$7.75 to \$8.75 by January 2015, and to \$9.75 by January 2016, with an automatic annual cost of living adjustment based upon the Anchorage Consumer Price Index or at least \$1.00 above the federal rate, whichever is higher built in for future years.

# Anchorage Vote "NO" On AO-37

As a union of public employees whose working conditions are administered through collective bargaining, Anchorage AO-37 has possible far reaching ramifications for all ASEA members. AO-37 is a brutal initiative that seeks shredding 40 years' worth of collective bargaining rights for Anchorage Municipal employees via the local legislative process. Over 21,000 referendum signatures for repeal were gathered - many by ASEA members and staff - to require a vote on its merits; or more importantly, its lack thereof. AO-37 went through the Alaska Supreme Court to determine when it could be put to a vote of the people. It has since been revised and was passed by the assembly only to be vetoed once again by the Mayor. It is now on the Ballot, and we need to seek its permanent end.

The stakes are high for ASEA State Employee Members - maybe never higher. Lieutenant Governor candidate Dan Sullivan crafted AO-37 as Anchorage Mayor. ASEA members need to send Sullivan a strong message: **Destroying Collective Bargaining won't be tolerated no matter what political position he holds.** Let's make our message loud and clear -

### Mark Begich for U.S. SENATE - (D)



Mark Begich is in his first term representing Alaska in the U.S. Senate. He was elected in 2008 after serving as Anchorage's mayor for six years.

I have a proven record of fighting for Alaska.

When members of Congress introduced a bill to limit the collective bargaining rights of public employees, I stood up to defend worker's rights and earned a lifetime AFL-CIO voting record of 97%.

#### I successfully:

- Pushed the Obama administration to allow drilling in the Arctic Ocean.
