Beginning July 1, 2015, the Fairbanks North Star Borough Supervisors (FNSB) are now able to contribute to the ASEA/ AFSCME Local 52 Political Action Committee (PAC) through a provision which was negotiated into your new contract.

With Article 4.04 (d) you now have the ability to have your

contribution taken as a payroll deduction. PAC Directors are given a voice and vote on the contributions to federal, state and local issues and candidates that the PAC votes to support.

AFSCME Scholarships Available

There are several AFSCME Scholarships available.

The <u>AFSCME Family Scholarship</u> is for graduating high school seniors ONLY, or children who are financially dependent, grandchildren whose parents are active dues paying members or retired members.

- •The application period opens August 1 and closes December 31, with the winners announced on March 31.
- •Ten (10) scholarships of \$2,000 each awarded annually.
- •Once awarded, scholarship will be renewed for \$2,000 each year up to four (4) years provided the student remains enrolled in full-time course of study.

The <u>Jerry Clark Memorial Scholarship</u> is available to children of active AFSCME members who are college sophomores with a social science major.

- The application period opens January 7 and closes April 30
- •Winners are announced August 1
- •Students must have a grade point average (GPA) of 2.5 or above
- •Two (2) \$500 scholarships per year are awarded for the College Junior and Senior years
- •Includes an internship with AFSCME's Political Action Department

<u>Union Plus Scholarship</u> program awards range from \$500 to \$4,000.

- •The application period opens June 14 and ends January 31
- •Winners announced May 3
 Available to union members' spouses and dependent children.

 National Labor College Scholarship helps union members and

leaders earn a Bachelor of Arts or Graduate degree while continuing their trade union work.

- •A total of \$25,000 in financial aid is contributed to the National Labor College Program each year
- Program is tailored to full-time working members, with online distance-education
- •Eligible students attending programs allow students to study and take classes at their own pace on their own schedule
