### On The Election Committee

The ASEA State Executive Board is seeking Statements of Interest from members who would like to serve as the Rural Representative on the ASEA/AFSCME Local 52 Election Committee.

In accordance with Article 7.05 D all ASEA elections shall be conducted under the supervision of an Election Committee. The Election Committee shall be responsible for making all necessary arrangements for the elections, including the mailing of notices of nominations and elections and the mailing and counting of ballots. The Election Committee consists of six (6) members; the committee chair and one (1) member representing each of the five (5) geographical regions in the Union. The Rural Region seat is currently vacant.

To qualify for appointment to the Rural Region seat you must be a member in good standing and your work location must be in the Rural Region. Also, to serve on the Committee you can't be a candidate for election or hold any other elected or appointed office in the Union, with the exception of serving as a Steward.
