\*(May 2018 - The ASEA State Executive Board voted unanimously to limit attendance at the AFSCME Biennial convention to the 6 members (president, secretary, treasurer and 3 at large delegates) as required by article 14.01 A & B of the ASEA constitution, due to sufficient funds not being available to send a full delegation.)
