WHERE IS THE PENSION BILL NOW?

Senate Bill 88 (SB 88) is one step away from a floor vote in the Senate. The bill is currently held in the Senate Finance Committee (co-chaired by senators Hoffman, Olson, and Stedman) where it received several hearings this spring. Senate leadership has signaled support for SB 88 and the bill is expected to advance early next session. Once the bill is in the House, support from ASEA members will be essential to keep lawmakers focused on advancing the bill through committees and a final floor vote before adjournment.



WHY DOES ASEA SUPPORT PENSIONS?

... Alaskans understand that quality public services exist when qualified people are hired to provide them. The time has come to reinvest in state employees by paying competitive wages that keep up with inflation, to restore a defined benefit (pension) retirement, and to end a tolerance for understaffing and a predisposition to outsource services to out-of-state contractors. Years in the making, the state's recruitment and retention crisis has cored out emerging career employees from joining the backbone of the public workforce at the expense of all Alaskans. Our public employees deserve better, and Alaska deserves better:

Recruitment and retention of qualified public employees has gone from challenge to crisis since the elimination of defined benefit pension in 2005.

Seeing the writing on the wall, the ARM Board passed a resolution critical of Total Retirement' Empower's 'My product outlined below:

- Managed Accounts like 'My Total Retirement' are expected to "continue to have lower investment performance due to the combined effect of its asset allocation. higher fees. and low participant engagement."
- The ARM Board "recommend[s] that the Department of Administration Managed Accounts to all new participants in any Alaska retirement plan."
