## **AFSCME Biennial Convention Delegate Election Report**

The ASEA Elections Committee has concluded the 47th AFSCME Biennial Convention election.

The ASEA Elections Committee conducted a count of the Statewide Election ballots for the AFSCME 47th International Convention Delegate Election. ASEA/AFSCME Local 52 has been allocated ten (10) delegate seats. Three (3) delegate seats are filled by the ASEA Constitution (President, Secretary, and Treasurer\*). The remaining seven (7) delegate seats are elected by a vote of the membership.
