### ASEA Judicial Committee – 5 Vacancies

An elected body of ASEA members established for the purpose of resolving internal union disputes. Vacancies to the Judicial Panel are filled by appointment until the next scheduled election (March 2025).

### ASEA Pride Committee – 4 Vacancies

For ASEA members who identify with the lesbian, gay, bisexual, transgender, and questioning (LGBTQ) community. The committee stands for legal equity and fair treatment for all employees. The committee's purpose is to identify opportunities and to recommend solutions for advancing these ideas.

### Class 1 Committee – 3 Vacancies

Created for and comprised of GGU Class 1 members to represent the needs of Class 1 employees. This committee meets monthly by telephonically.

### Conservative Caucus Committee – 10 Vacancies

Created to study and address the concerns of conservative members and to enhance their identification with and engagement in our union.

### DOT Special Issues Committee – 8 Vacancies

Created for ASEA members who work for the Alaska Department of Transportation or a municipal transportation department. The Committee's purpose is to identify worksite opportunities and concerns, and to recommend solutions.

### DPA Committee – 4 Vacancies

Created for ASEA members who work for the Alaska Department of Health & Social Services, Division of Public Assistance. The Committee's purpose is to identify worksite opportunities and concerns and to recommend solutions.

### Grievance Review Committee – 5 Vacancies

An eight-member committee of experienced stewards (2+ years as an ASEA Steward) established for the purpose of addressing member grievance procedure appeals, governed by ASEA Policies & Procedures.

### Information Technology Committee – 10 Vacancies

Created to address issues and concerns of Information Technology (IT) employees and recommend solutions.

### Next Wave Committee – 6 Vacancies

Created for ASEA members who are either newly active or 40 years of age and under, to recruit, engage, educate and address issues and concerns of those members.

### Nurses Committee – 4 Vacancies

Created for ASEA members who work as a registered nurse, license practical nurse, or certified nurse aide. The Committee's purpose is to identify opportunities and to recommend solutions for advancing quality and accountability in the healthcare setting.

### Veterans Committee – 6 Vacancies

The Committee's purpose is to advocate for and support activities within ASEA/AFSCME Local 52 that are of special interest to veterans.

### Women's Issues Committee – 5 Vacancies

The Women's Issues Committee was created for members to address challenges, inequalities, and recommendations for improving working conditions for ASEA Women.

### Bush Community Committee – 10 Vacancies

Created for the Bush community members, to address issues and concerns of chapters not on a road system and to look into economic impacts and union opportunities. Bush chapters include Ketchikan, Cordova, Petersburg, Sitka, Bethel, Dillingham, Nome and Kodiak- Aleutians.

### Probation & Parole Committee – 1 Vacancy

Created to address issues and concerns of Probation and Parole Officers. The committee meets monthly by teleconference.
